

Appendix 1 - Schedule of Lands

This schedule identifies the community land under Council's ownership and the categories that have been applied to that land. The categories identified for a particular park or reserve indicates that the park/reserve is covered by the relevant generic plan(s) that apply to that category of land, except where individual Plans of Management have been developed. Generic plans have been developed for Parks, Natural Areas, Sportsgrounds and General Community Use Areas.

For consistency of management, the Schedule incorporates parks and reserves under Council's Care and Control. To assist in understanding, land ownership is included within the Schedule.

In instances where more than one category applies to a specific park or reserve then reference should be made to the relevant Community Land Category Map contained in Appendix 2, to determine the location of each category.

Some parks and reserves may have individual plans developed subsequent to the development of this Plan. In areas of conflict between a generic plan of management and a specific plan of management the specific plan will have precedence.
