**REPORT:**

Correspondence has been received from the Hon. Jim Lloyd, MP, Federal Minister for Local Government, Territories and Roads, advising of successful funding under the Auslink Strategic Regional Programme for safety improvements to the intersection of Bells Line of Road/Old Bells Line of Road/Mill Road, Kurrajong. Council has been offered an Australian Government contribution of \$750,000 (capped) for this project.

The funding offer is conditional upon the project being completed by June 2010; and a funding agreement being entered into between Council and the Department of Transport and Regional Services.

**Conformance to Strategic Plan**

The proposal is deemed to conform with the objectives set out in Council's Strategic Plan i.e:

*"Objective: A network of towns, villages and rural localities connected by well-maintained public and private infrastructure, which support the social and economic development of the city."*

**Funding**

Funding to be provided from the Auslink Strategic Regional Programme.

**RECOMMENDATION:**

That the offer of funding under the Auslink Strategic Regional Programme for safety improvements at the intersection of Bells Line of Road/Old Bells Line of Road/Mill Road, Kurrajong in an amount of \$750,000 (capped) be accepted.
