### Exhibition of the Draft Naming of Roads and Places Policy

Council at its Ordinary Meeting on 22 November 2022 resolved to place on exhibition the 'Draft Naming of Roads and Places Policy'.

The 'Draft Naming of Roads and Places Policy' will be on public exhibition from the Wednesday, 14 December 2022 to Friday, 27 January 2023.

The purpose of the 'Naming of Roads and Places Policy' is to support names in providing a link between the community and the country or places in which the names appear. Names can also reflect the history of our communities. This Policy supports recognition of First Nations peoples, cultures and histories in the naming of places in the public domain.

The 'Naming of Roads and Places Policy' applies to all parks, open spaces, roads and buildings owned, operated or managed by Hawkesbury City Council.
