- + MULTI-PURPOSE ROOM TO PROVIDE FOR A 14 PERSON BOARDROOM CONFIGURATION AND 30 PERSON TOWNHALL MEETING
- + MULTI-PURPOSE ROOM TO INCLUDE CHAIR/TABLE/FURNITURE STORE
- + INCLUSION OF SEPARATE STORAGE AREAS FOR ADMIN. & REP. TEAM GEAR
- + INCLUSION OF SPORTS COUNCIL OFFICE WITH SECOND ENTRY AND SEPARATE ARCHIVE STORE ROOM
- + INCLUSION OF SHARED KITCHENETTE AND SINGLE WC FOR ADMIN. STAFF
- + CANTEEN TO INCLUDE CENTRAL PREP. BENCH AND SEPARATE STORE
- + INCLUSION OF PARENT'S ROOM, PRIMARILY FOR PLAYER USE
- + PUBLIC TOILETS TO BE ACCESSED SEPARATE FROM NETBALL FACILITY
- + PUBLIC TOILET NUMBERS TO MATCH EXISTING ON SITE
- LAYOUTS TO ALLOW STAGED DELIVERY OF THE FACILITY


NOTE

The public toilets in the pavilion are not designed to cater for moderate to large numbers of players, officials and spectators. The floor area for the toilets is based on the assumption that there will be other public toilet facilities (permanent or temporary) located within easy walking distance (< 150m) of the netball facility.



02 SITING PRINCIPLES




- 1 NETBALL 'PUBLIC' INTERFACE (KIOSK AND MULTI-FN ROOM) LOCATED TO ENGAGE ARRIVAL PATH FROM CARPARK & COURTS
- 2 COVERED HARDSTAND AREA FOR BBQ AND COMMUNITY USE
- 3 PUBLIC TOILETS ORIENTED TOWARD PLAYGROUND FOR PROXIMITY AND SURVEILLANCE
- 4 GAME-DAY FUNCTIONS ARE COURT-FACING, OPENING OUT TO COVERED AREA

- 5 ADMIN. AREAS ARE STREET-FACING FOR PASSIVE SURVEILLANCE
- 6 NETBALL AMENITIES TO SERVE PLAYERS/UMPIRES & OFFICES
- 7 CONTINUOUS COVERED 'COMMUNITY CANOPY' GAME DAY & SPECTATOR AREA
- 8 BREAK-OUT LAWN FOR SPECTATORS AND EVENTS
- 9 EXPANDED CENTRAL THOROUGHFARE TO COURTS




