### **PANEL DECISION:**

The Panel unanimously resolved that:

The Hawkesbury Local Planning Panel as the consent authority defers determination of this matter for a period of three months (21 July 2022), being Development Application No. DA0196/20 for the use of two buildings identified as the Enchanted Cave and Treehouse as tourist facilities on Lot 3 in DP 270515, known as 88B Bulgamatta Road, Berambing, for the following reasons:

### **Reasons for Deferment**

- 1. The applicant has requested that the matter be deferred to give him an opportunity to submit a development application for an eco-tourist facility on the subject land that includes use of the buildings subject to DA0196/20.
- 2. The panel anticipates that council will prepare a report for the panel on the status of any new development application for the subject land.
