I/we further agree to ensure that Council's requirements as listed hereunder are complied with in every respect and accept full liability to ensure that these works will be constructed in strict compliance with Council's Driveway Specification and Conditions as follows:

- A minimum of **24 hours notice** is required for all inspections to be booked by the Owner/Contractor;
- Should the second inspection of the formwork be rejected by non-compliance with Council's Specifications or conditions of approval, **an additional inspection fee of \$84.35 will be paid prior to each and every inspection thereafter;**
- Pedestrians shall be permitted adequate and safe use of part of the footpath or, alternatively, a properly barricaded passage along the roadway, if required, and should be placed so as not to impede the flow of vehicular traffic;
- Should the finish of the concrete not be of a suitable standard or any alterations be made after the formwork has been approved, I accept Council's decision to remove and replace this structure at my expense at any such time as it is deemed necessary by Council.
- A Public Risk Liability Policy to the amount of \$10,000,000 to be obtained by the Owner/Contractor to cover all works undertaken on public property. **Please forward Certificate of Currency for Public Risk Liability Insurance Policy, confirming current insurance policy exists.**
