FEES AND SERVICES

EFFECTIVE 1 JULY 2025

Free Materials – (domestic quantities only)

- Household recyclables
- Paper and cardboard
- Scrap metal (EXCLUDING fridges, freezers & air con units and car bodies)
- Car batteries
- E-Waste
- Sump oil (to be poured into the holding tank)
- Paint (up to 100L max)

Prohibited Materials

- Liquids, chemicals
- Compressed fibre sheeting
- Vinyl/ lino
- Cement fibre reinforced products
- Asbestos and products containing asbestos
- Fibre cement sheeting
- Fibro (of any kind – old or new)
- Soil (any amounts)
- Others (as designated by Council)
- Villaboard/ blueboard

How to use this facility

All vehicles must enter and exit the Facility via the weighbridge.

Closed circuit television records images of all vehicles entering and exiting the site and stores these images along with vehicle and transaction information.

Charges are set according to weight and waste type.

After you have disposed of your waste, follow the signs to the exit point where you will drive onto the exit weighbridge (when the light is green). The exit weight of the vehicle is automatically deducted from the entry weight and the relevant charges calculated.

Any load containing or suspected of containing prohibited materials, will be directed to leave the facility, without unloading any materials.

The Hawkesbury City Waste Management Facility receives domestic and **select other materials** from within the Hawkesbury Local Government Area (LGA) and from the neighbouring LGA's of Blacktown, Penrith, The Hills, and Blue Mountains.

ENCLOSED FOOTWEAR MUST BE WORN

For Hawkesbury residents and businesses, to ensure you receive the applicable Hawkesbury LGA fees you must provide Proof of Residency. Your current drivers licence is acceptable for domestic materials from your home address. Hawkesbury Commercial Customers or persons bringing materials from properties other than their own address will need a current Hawkesbury Council Rates Notice to receive the Commercial Hawkesbury LGA fees.

Persons without the required documentation will be required to pay the applicable fees for outside the LGA customers.

PRICES INCLUDE THE NSW EPA WASTE LEVY OF \$174.20 PER TONNE

General Waste (no recyclables)

20kg or less = \$99

More than 20kg = \$99 base fee + \$520 per tonne

General Waste (with recyclables)

20kg or less = \$280

More than 20kg = \$280 base fee + \$1100 per tonne

Timber

20kg or less = \$99

More than 20kg = \$99 base fee + \$620 per tonne

Building and Demolition Waste

20kg or less = \$99

More than 20kg = \$99 base fee + \$640 per tonne

Brick and Concrete

20kg or less = \$99

More than 20kg = \$99 base fee + \$235 per tonne

Insulation, Polystyrene, Difficult to Handle/ Special Waste

20kg or less = \$560

More than 20kg = \$560 base fee + \$3500 per tonne

Green Waste Vegetation (100% vegetation only)

Excludes palm, yucca, bamboo, rootballs, stumps, weeds and other non-mulchable garden organics |
NO SOIL (prohibited) = \$230 per tonne

Animals

20kg or less = \$38

More than 20kg = \$38 base fee + \$560 per tonne

Other Materials

Mattresses (all sizes) = \$49

Fridge/ freezer/ air conditioning units = \$44

Tyres (4WD/passenger car & smaller)

(max 5 per load) = \$25

Oil containers = \$3 each
