Tenders are invited for Culvert replacement Tizzana Road over Jubilee Vineyard Creek and will be received up to 3pm on Wednesday, 16 August 2023.

Proposal is to Replace the existing approximately a 5-metre diameter, corrugated steel pipe with a twin cell 2.7m diameter Reinforced Concrete pipes Culvert (RCP) or a twin cells 3.0m diameter Corrugated Metal Pipes culver (CMP). Replacing with either RCP or CMP culverts will improve the live cycle, road safety and flows through the culvert and it will only require minimal maintenance.
