The recognition in becoming a finalist or a winner adds credibility as a successful local business.

The Awards logo has become a symbol of an outstanding business. The 2024 Hawkesbury Local Business Awards will be held on Wednesday, **13 November 2024** at the Hawkesbury Race Club.

Finalists are selected based on the number of nominations they receive from the public. The more nominations received, the better the chance of being selected as a Finalist.

The number of nominations required to become a finalist varies for each category. This is determined by the foot traffic of each industry. 
Local Business Sponsorship Opportunities for Savour the Flavour and Light Up Windsor

<u>Spendmapp</u>, developed by Geografia, is an economic modelling tool used by several local government areas to measure consumer spending of locals and visitors geographically using bank data.

The tool helps local council's and businesses gain a better understanding of the local economy by providing an insight into the visitor economy, online expenditure and escape expenditure. Using the data helps determine patterns of spending and can assist with managing and responding to long term economic trends and shocks.




May's visitor spending had an increase in *Transport*, *Professional Services*, *Specialised & Luxury Goods* and *Grocery Stores & Supermarkets* from the previous month. Meanwhile there was a decrease in spending for *Dining & Entertainment*.

This May, the category *Professional Services* has replaced *Specialised Food Retailing* to be in the top 5 categories of visitor spending.

Resident spending in May shows an increase in all categories.

Federal budget 2024-25: Information for small businesses

The latest results from the Commission's Momentum Survey reveals significant challenges remain for the small business sector. The Federal Government released the 2024-25 Budget containing several new measures for small business. Key announcements for small businesses include:

- The extension of the \$20,000 instant asset write-off for depreciating assets until 30 June 2025
- A \$325 energy bill relief rebate for eligible small businesses
- The removal of <u>457 nuisance tariffs</u> on a range of imported goods from July 1 to reduce compliance costs
- Investment into 20,000 free TAFE places in courses relevant to the construction sector, in addition to the 300,000 fee-free TAFE places in areas of priority skills.


