COVID-19 Update



Restrictions Eased in LGAs of Concern

Restrictions in local government areas of concern have begun to ease as vaccination rates continue to rise in Sydney's West and Southwest.

From Monday, 20 September the following restrictions were eased in LGAs of concern:

- No limit on the duration of outdoor exercise and recreation (previously a two-hour limit);
- Outdoor gatherings of up to five fully vaccinated people (not including children aged 12 and under) will be allowed in a person's LGA or within 5km of home (previously only fully vaccinated household members could gather outdoors, or up to two fully vaccinated people from different households):
- Shopping, exercise and outdoor recreation can be done 5km from home or within your LGA (previously only 5km from home);
- Attend a <u>small wedding</u> (maximum 11 people) in Greater Sydney as a guest (previously only allowed in their LGA); and
- A person's single's bubble buddy can live in Greater Sydney (previously must have resided within 5km of a person's home). A person from a LGA of concern can also now be a buddy for someone in Greater Sydney.

Nearly all restrictions in the LGAs of concern are now aligned with other lockdown areas, with the main differences being authorised <u>worker conditions</u> and <u>travel permit</u> requirements which remain in place in the LGAs of concern.

Reopening NSW Roadmap

NSW will start to reopen, with stay-at-home orders lifted, the Monday after the state passes its 70% double vaccination target.

- Only fully vaccinated people and those with medical exemptions will have access to the freedoms allowed under the Reopening NSW roadmap
- Non-vaccinated young people aged under 16 will be able to access all outdoor settings but will only be able to visit indoor venues with members of their household.
 - Examples of indoor venues that they can only attend if they are with a vaccinated member of their household include: an indoor hospitality avenue, entertainment facilities and major recreation facilities.
- Employers must continue to allow employees to work from home if the employee is able to do so.
- There will be revised guidance on isolation for close and casual contacts who are fully vaccinated, with details to be provided closer to the reopening date.
- When NSW hits the 80% double dose target, the government intends to open up further freedoms around international travel, community sport, major events and other areas.

Free Advice on Vaccination and other Employee Issues

Small businesses can apply to receive free advice on employee pay and entitlement issues, including those that relate to vaccination, through the Fair Work Ombudsman's Employer Advisory Service (EAS).

Recently launched, the EAS provides small businesses with up to four hours of free legal advice. Minimum conditions to access the service are:

- the employer is covered by the Fair Work system and has less than 15 employees at the time of the enquiry
- the enquiry relates to pay and entitlements under the National Employment Standards or award provisions
- the employer is happy for an EAS adviser to contact them and discuss their enquiry in more depth.

COVID-19 Support Payments Expanded

The NSW Government has announced an additional \$287.5 million in COVID-19 financial support to assist workers and vulnerable communities in metropolitan, regional and rural NSW.

The additional funding will see emergency hardship payments, test and isolate support payments and community empowerment grants expanded across the State.

Extreme Hardship Support Program

The Australian Red Cross has received funding from the NSW Government to provide emergency financial relief for people in New South Wales to help meet their basic needs, such as food, medicine and shelter. This is specifically for those who do not have access to Commonwealth income support (including Job Seeker and SRSS).

Test and Isolate Support Payment

If you need to self-isolate and are unable to work while waiting for your coronavirus (COVID-19) test result, you may be eligible for the COVID-19 Test and Isolate support payment.

NSW workers can apply for the \$320 payment if they:

- Meet the <u>eligibility criteria</u>
- Agree to follow NSW Health self-isolation guidelines while waiting for their COVID-19 test result

Note: you will need to apply for the payment within 7 days of having the test.

Assistance Measures for Small Businesses

COVID-19 Business Grant

If you're a business, sole trader or not-for-profit organisation in NSW and you've been impacted by the recent COVID-19 restrictions, you may be eligible for a one-off grant of \$7,500, \$10,500 or \$15,000.

The 2021 COVID-19 business grant provides support for businesses that experienced reduced demand or had to close due to the public health orders. It will provide businesses across NSW with cash flow support for the first 3 weeks of the restrictions (26 June to 17 July 2021).

Micro-Business Grant

If you are a micro-business with an annual turnover between \$30,000 and \$75,000 and have been impacted by the recent lockdown and restrictions, you may be eligible to receive a fortnightly payment of \$1,500.

Small Business Fees and Charges Rebate Scheme

Small businesses are encouraged to take apply of the NSW Government's \$1,500 rebate scheme to help cover the cost of NSW and local government fees and charges. The rebate is open to small businesses that have a total wages bill below the new 2020-21 \$1.2 million payroll tax threshold. The rebate is available until 30 June 2022, for eligible fees and charges due and paid from 1 March 2021. Click HERE for more information.

Tax Relief

Tax relief support is available for New South Wales businesses impacted by COVID-19.

2021 payroll deferral

- Payroll tax customers have the option of deferring their payroll tax payments until 14 January 2022
- All customers are still required to lodge the 2020/21 annual reconciliation by the due date, which has been extended to 14 January 2022
- In addition, customers have the option of deferring their payments for the July to December 2021 return periods until 14 January 2022
- Customers will have the option of paying all of their outstanding liability in full or entering into a new Support Payment Arrangement
- If customers choose to enter into a 2021 Support Payment Arrangement, they will have the option to include tax payable from the 2020/21 annual reconciliation and any monthly liabilities for the July to December 2021 return periods

Reduction in 2021/22 payroll tax liability

A 50% reduction in payroll tax liability is available to businesses whose total grouped Australian wages for the 2021/22 financial year are \$10 million or less who experience a 30% decline in turnover.

Commercial Lease Protections

The NSW Government has introduced protections to mandate rent relief for commercial tenants impacted by the COVID-19 lockdown and supports for landlords who provide that relief.

The Retail and Other Commercial Leases (COVID-19) Regulation 2021 has been amended to mandate rent relief for eligible tenants and the prescribed period extended to 13 January 2022. The Regulation requires landlords to provide rent relief in proportion to their tenant's decline in turnover.

Tenants and landlords unable to reach agreement on rent relief are required to take part in mediation conducted by the NSW Small Business Commission.

Land tax relief is available for landlords who have reduced their tenants' rent due to COVID-19, between 1 July 2021 and 31 December 2021. More information is available <u>HERE</u>.

Tourism and Accommodation Support Package

The NSW Government has introduced a <u>tourism support package</u> which includes measures to support jobs in the accommodation, entertainment and tourism sectors. Eligible accommodation businesses with a physical location in the City of Sydney local government area can <u>register for the Stay & Rediscover</u>
Accommodation Voucher Scheme.

COVID Development Grants

Individual artists and small to medium arts and cultural organisations impacted by COVID-19 restrictions can now apply for COVID Development Grants to support the development of new work. Grants of up to \$5,000 for individuals and groups, and up to \$10,000 for small to medium organisations can be applied for through Create NSW. Applications for the COVID Development Grants are now open on the Create NSW website.

Assistance for Indigenous businesses

Indigenous Business Australia (IBA) is providing support to eligible Indigenous businesses impacted by COVID-19, including those that are not existing IBA customers. Assistance may include loan deferrals, grants or a combination of both to help with ongoing fixed costs through the COVID-19 crisis. JobSaver Payments for Businesses and Not-for-Profits

The NSW Government's JobSaver program provides fortnightly payments to help maintain employee headcount and provide cash flow support to businesses.

How much

- Employing businesses: 40% of their weekly NSW payroll, with payments between \$1,500 and \$100,000 per week
- Non-employing business: \$1,000 per week.

Eligibility

- A revenue decline of 30% or more
- Turnover between \$75,000 and \$250 million.

JobSaver for large hospitality, tourism or recreation businesses

Fortnightly payments to help maintain employee headcount and provide cash flow support to large businesses. commencing from the 26 June 2021 lockdown only.

How much

Payments of 40% of weekly payroll prior to the 26 June 2021 lockdown, up to a maximum weekly payment per group of:

- \$300,000 for businesses with aggregated annual turnover over \$250m and up to \$500m
- \$500,000 for businesses with aggregated annual turnover over \$500m and up to \$1b.

Eligibility

A turnover decline of at least:

- 50% for businesses with aggregated annual turnover over \$250m and up to \$500m
- 70% for businesses with aggregated annual turnover over \$500m and up to \$1b.



Support for Accommodation Providers

Accommodation provider support payments will be available in late September 2021 for eligible tourism accommodation providers that have lost business during the school holiday period. Assistance will be based on the number of cancelled room nights.

How much

- \$2000 for up to 10 room nights.
- \$5000 for 11 or more room nights.

Eligibility

• For room nights lost during the 25 June to 11 July period.

• Must be able to show evidence of cancellations.

Accommodation providers are also encouraged to check their eligibility and apply for other <u>business</u> <u>support</u>, including the COVID-19 business grant, JobSaver, COVID-19 Micro Business Grants and payroll tax reductions.

Hawkesbury Local Heritage Assistance Fund 2021/2022

Hawkesbury City Council and Heritage NSW are jointly funding the Hawkesbury Local Heritage Assistance Fund 2021/2022.

The Funding Program recognises the importance of conserving, protecting and caring for heritage listed properties within the Hawkesbury Local Government Area and will provide funding assistance for minor maintenance/conservation works.

Council is now inviting applications from owners or managers of local heritage listed properties within the Hawkesbury Local Government Area seeking financial assistance under the Local Heritage Assistance Fund 2021/2022. Funding is offered to successful applicants on a dollar for dollar basis (\$1 of grant funding for each \$1 of private funding). The maximum funding available for any one applicant/property is \$2,000 (including GST).

Applications are open until Monday, 4 October 2021.
