REPORT:

Each year the Federal Department of Infrastructure, Transport, Regional Development and Local Government conducts the National Awards for Local Government.

As stated by the Minister in his recent Press Release, "the ongoing theme of the Awards is "Local Government - working hard for Australians" and it showcases the resourcefulness and innovation of Australia's hard working councils in improving services to their communities."

In 2008, 71 councils took part in the Awards, submitting 114 entries from across Australia. The Department's website describes these Awards as follows:

"The National Awards for Local Government were created to identify local government projects that are first rate or show new ways of dealing with the challenges a council faces. The National Awards promote these projects and councils so that other local government bodies can learn from the winning councils' projects and their experiences and not have to 'reinvent the whee!'.

The 2008 Category and Commendation winners were announced by Ministerial Press Release and on the Department's website on 4 September 2008 and I am pleased to advise Council that for the **Innovation in Regional Development** Category Hawkesbury City Council has been announced as the category winner for its entry in respect of *"Peppercorn Services Inc; A model for Social Entrepreneurship in Local Government"*.

This is a very pleasing result of which the Council, and staff concerned, can be justifiably proud, and recognizes the innovative approach that the Council has taken in establishing the "Peppercorn Services Inc." model.

The next step is for all category winners to present their entries to a national judging panel at the end of this month and arrangements will be made for Council to be represented by the Executive Manager - Community Partnerships.
