Expression of Interest

The Hawkesbury Regional Gallery welcomes expressions of interest from artists and art groups for exhibitions to be included as part of its exhibition program. The Gallery's exhibition program aims to provide a diverse range of artistic projects, themes and media over the year through a combination of touring and in-house produced exhibitions. Exhibition planning is usually two years in advance of the schedule.

The gallery has two distinct spaces – (A) a small self-contained gallery space of 8 x 3 metres and (B) a large space of 23 x 15 metres with moveable walls that divide the space into different configurations. Artists interested in the large space (B) will usually be displayed alongside one or two other exhibitions due to the size of the space. The large space also includes a projection room. Each space has a number of architectural features such as windows and doors to consider when planning how to use the space. The Gallery has multimedia equipment and exhibition furniture. Architect plans and equipment details are available on request.

Selection Process

Each expression of interest will be assessed by the Gallery selection committee once/twice a year in March/October. The assessment is based on selection criteria and the availability of the space. Hawkesbury Gallery endeavours to select proposals representing a variety of artists and art mediums.

Criteria for selection are:

- · Participating groups or individuals are preferably based in Western Sydney or the Blue Mountains
- Artistic merit or originality of proposed exhibition
- Exhibitions that explore or address subjects relevant to the Hawkesbury region (i.e. environmental, social, historical)

If selected for exhibition artists and groups agree to work in partnership with the gallery and staff to realise their exhibition as a part of the Hawkesbury Regional Gallery exhibition program. As part of the exhibition agreement with the gallery, artists and groups agree that the gallery's decisions in the administration and management of the exhibition are final.

Please complete the **Expression of Interest** form and submit it with the required support material. Please note Hawkesbury Regional Gallery is unable to assess your proposal without support material. Please do not submit original works with your application.
