RESCISSION MOTION:

That Council's resolution in respect of Item 119 of 28 June 2016 be rescinded.

NOTE BY MANAGEMENT:

The Mayor has received a request signed by Councillors Dr W Mackay (OAM) and J Reardon requesting that he call an Extraordinary Meeting of Council to consider a rescission motion lodged in respect of Item 119 of the Council meeting of 18 June 2016, concerning the holding of a constitutional referendum at the Council Government Election on Saturday, 10 September 2016 regarding the Hawkesbury local government area being divided into wards.

In accordance with the requirements of Clause 2.1.4 of Council's Code of Meeting Practice, the Mayor has called an Extraordinary meeting of Council to be held on Tuesday, 12 July 2016 commencing at the conclusion of the Ordinary meeting of Council, also being held on Tuesday, 12 July 2016 (commencing at 6:30pm) in the Council Chambers for this purpose.

Council's resolution from the meeting of 28 June 2016, in respect of this matter was:

"That:

- 1. Council hold a constitutional referendum at the Local Government Election on Saturday, 10 September 2016 regarding the Hawkesbury local government area being divided into wards.*
- 2. The constitutional referendum question relating to the Hawkesbury local government area being divided into wards be as follows:*

"Currently Hawkesbury City Council is an undivided council with no wards.

Do you agree to the Hawkesbury local government area being divided into three wards, each ward electing four Councillors?"
